### **Eligibility of Contractor**

[for 1st Call] Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of 40% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, ii) Intending tenderers should produce credentials of 2(two) similar nature of completed work, each of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i) above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be

clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer. (Vide notification No. 04-A/PW/O/10C-02/14 Dt:- 18.03.2015)

2) Cost of tender paper and earnest money should be deposited online by RTGS/NEFT in favor of MUNICIPAL AFFAIRS DEPARTMENT // URBAN LOCAL BODIES // HOWRAH MC.

3) As per memorandum no- 4608-F(Y) dt:-18july 2018 of additional chief secretary, Finance department, Govt. of West Bengal, Additional performance security is required when the bid rate is 80% or less of the estimate put to tender and no increase in scope of work of projects during execution phase- Additional performance security @ 10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the estimate put to tender. The additional performance security shall be submitted in the form of Bank Guarantee from any scheduled bank before issuance of the work order. If the bidder fails to submit the additional performance security within seven working days from the date of issuance of letter to acceptance, his earnest money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor, etc, may be taken. The bank Guarantee shall have to be valid up to end of the contract period and shall be renewed accordingly, if required. The bank guarantee shall be returned immediately on successful competition of the contract. If the bidder fails to complete the work successfully, the additional performance security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from the progressive bills of the contractor as per relevant clause of the contract shall in no way altered/affected by provision of the additional performance security.
