Assistant Engineer (WS), Howrah Municipal Corporation invites E-Tenders (in prescribed form) from reputed resourceful & bona-fide contractors who have **[for 1st Call]** i) Intending tenderers should produce credentials of a similar nature of work, of minimum value of 40% of the estimated amount put to tender during Five (5) years prior to the date of issue of the tender notice Or (ii) Intending tenderers should produce credentials of a similar nature of 2 work each of minimum value of 30% of the estimated amount put to tender during last five (5) years prior to the date of issue of the tender notice. Or (iii) Intending tenderers should produce credentials of one (1) single running work of similar nature of the minimum value of 80% or more and value of which is not less than the desire value at (i) above In case of running works, only those tenderers who will submit the certificate of satisfactory running work from their concerned Executive Engineer of equivalent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e the tenderer. **[for 2nd Call]** (i) Intending tenderers should produce credentials of a similar nature of work of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice **or**, (ii) Intending tenderers should produce credentials of 2 (two) similar nature of work, each of the minimum valve of 25% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice **or**, (iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 75% or more and value at (i) Above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned executive engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executive agency, i.e, the tenderer. **[for 3rd/ subsequent Call]** i) Intending tenderers should produce credentials of similar nature of completed work of the minimum value of 20% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, ii) Intending tenderer should produce credentials of one single running work of similar nature which has been completed to the extent of 70% or more and value of which is not less than the desired value at (i) above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer. (Vide notification No. 04-A/PW/O/10C-02/14 Dt:- 18.03.2015) & must full fill the terms and condition of Annual Maintenance work of pipe line under Water Supply Department given below.
