## NOTICE INVITING e-TENDER

Executive Engineer (Crematorium). Howrah Municipal Corporation invites e-Tender in prescribed form from reputed resourceful & bonafide Contractors/ Firms having previous experience in similar nature of job as per particulars given below. [for 1st Call] i) Intending tenderers should produce credentials of a similar nature of work, of minimum value of 40% of the estimated amount put to tender during Five (5) years prior to the date of issue of the tender notice Or (ii) Intending tenderers should produce credentials of a similar nature of 2 work each of minimum value of 30% of the estimated amount put to tender during last five (5) years prior to the date of issue of the tender notice. Or (iii) Intending tenderers should produce credentials of one (1) single running work of similar nature of the minimum value of 80% or more and value of which is not less than the desire value at (i) above In case of running works, only those tenderers who will submit the certificate of satisfactory running work from their concerned Executive Engineer of equivalent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e the tenderer. (Vide notification No. 04-A/PW/O/10C-02/14 Dt:- 18.03.2015) Intending Tenderers will have to apply through online with self attested photo copies of valid Pan Card, GST, P.T, ITR, Trade License along with proper credentials of similar nature of works regarding their ability to execute the work etc. duly signed by the applicant with the seal of the firm / company.
