Executive Engineer, Howrah Municipal Corporation invites e-Tender in prescribed form from reputed resourceful & bona-fide Contractors/ Firms having previous experience in similar nature of job as per particulars given below. [for 2nd Call] (i) **Intending tenderers should produce credentials of a similar nature of work of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice or, (ii) Intending tenderers should produce credentials of 2 (two) similar nature of work, each of the minimum value of 25% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice or, (iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 75% or more and value at (i) Above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned executive engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executive agency, i.e, the tenderer.** (Vide notification No. 04-A/PW/O/10C-02/14 Dt:- 18.03.2015) Intending Tenderers will have to apply through online with self attested photo copies of valid Pan Card, GST, P.T, ITR, Trade License along with proper credentials of similar nature of works regarding their ability to execute the work etc. duly signed by the applicant with the seal of the firm / company. 
