Intending Tenderers will have to apply through online with self attested photo copies of valid Pan Card, GST, P.T, ITR, Trade License along with proper credentials of similar nature of works of work value in single order executed within last 5 (Five) years regarding their ability to execute the work etc. duly signed by the applicant with the seal of the firm / company. [for 1st Call] (i) Intending tenderers should produce credentials of a similar nature of work of the minimum value of 40% of the estimated amount put to tender during last 5 (five) years prior to the date of issue of the tender notice or, (ii) Intending tenderers should produce credentials of 2 (five) years prior to the date of issue of the tender notice or, (iii) Intending tenderers should produce credentials of one single running work, each of the minimum valve of 30% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice or, (iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value at (i) Above; In case of running works, only those tenderers who will submit the certificate of satisfactory running the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e, the tenderer.] (Vide notification No. 04-A/PW/O/10C-Defect of the tender).
