Terms and Conditions

- F.O.R destination at Motor Vehicles Department, HMC, Bally Office, 103, Dewangazi Road, Bally, Howrah.
- Quoted rate should be valid for at least for 90 days from the date of the opening of the same.
- Quotation must be quoted on the official letter head of the firm with duly signed and stamped, otherwise quotation may be rejected. The Price Bid format has been given in Annexure-II. The same format is to be printed on the official letter head of the Bidders and rates should be mentioned there properly.
- Rate quoted should be inclusive of all taxes (as applicable).
- 5. The supply of Spare Parts should be made within 20 (Twenty) days from the receipt of the Purchase Order. If the supply delayed beyond the stipulated time of the completion of supply penalty of 01% per weeks of total cost may be imposed at the discretion of competent authority. The penalty may be upto 10% of the total cost.

SPECIFICATION, FEATURES & GENERAL REQUIREMENTS OF MUDGUARDS AND DRIVING SEATS

Features of Mudguards:

- Strictly to the actual Model and Specification of the Manufacturer
- · Important skin panel component on tractor
- Strength and aesthetics equally important

Load Capacity: Min 160 Kg.

1.The dimensions for Driving Seat of Tractor are as follows:

- 1.1 Seat height: Approx 380 mm,
- 1.2 Seat pan width: Approx 420-450 mm,
- 1.3 Seat backrest width: Approx 380-400 mm (bottom) and 270-290 mm (top),
- 1.4 Seat pan length: Approx 370±10 mm,
- 1.5 seat pan tilt: 5-7° backward
- 1.6 Seat backrest height: Approx 350 mm.

2. The driver's seat must be installed in such a way that:

- 2.1 the driver is assured of a comfortable position for driving and maneuvering the tractor.
- 2.2 the seat is easily accessible;
- 2.3 the driver, when seated in the normal driving position, can easily reach the various control devices of the tractor that are likely to be actuated during operation;
- 2.4 No part of any of the seat or tractor components is likely to cause the driver to suffer cuts or bruises



3 General requirements

- 3.1 The driver's seat must be designed to ensure a comfortable position for the driver when controlling and manoeuvring the tractor, and to afford him the utmost protection as regards health and safety.
- 3.2 The seat must be adjustable in the longitudinal direction and in the height without the use of a tool.
- 3.3 The seat must be designed to reduce shocks and vibration. It must therefore be well sprung, have good vibration absorption and provide adequate support at the rear and sides. The lateral support is considered adequate if the seat is designed to prevent the driver's body from slipping sideways.
- 3.3.1 The seat must be suitable for persons of different mass. Any adjustment necessary in order to comply with this requirement must be carried out without the use of tools.
- 3.4 The seat surface, the backrest, the lateral supports and, where fitted, the removable, folding or fixed armrests, must be padded and the coating material must be washable.
