Like previous instance, in absence of inclusion of the provision for submission of on-line "Mandatory Declaration" with regard to compliance of various Environment related directions / guidelines issued by the competent authorities from time to time in the concerned Portal by the Puja Committees while applying "NOC" for the up-coming Sharodotsav as a pre-condition for getting such permission, it is requested to kindly direct the Puja Committees to submit the hard copies of the Mandatory Declaration as per the pro-forma enclosed duly signed by the President / Secretary of the Puja Committees with affixing official stamp on it and deposit the same at the respective Police Stations latest by 10.10.2023 so as to enable the HMC to issue "NOC" only on receipt of the same from the Police authority.
